

# Overtime for Professional Staff Policy

## **Section 1 - Background**

(1) This Policy has been developed to explain the Overtime provisions for Professional Staff at Australian Catholic University (ACU), as set out in the <u>ACU Staff Enterprise Agreement 2022-2025</u>.

## **Section 2 - Purpose**

(2) To facilitate the operations of the University, from time to time a professional staff member may be required to work overtime. When a professional staff member is directed to work overtime, they will either receive payment for working the overtime or may elect to take time off in lieu in accordance with the provisions of this Policy.

## **Section 3 - Scope**

(3) The provisions of this Policy apply to professional staff members, who receive a salary up to and including HEW Level 10 and should be read in conjunction with the <u>Flexible Working Arrangements Policy</u>.

# **Section 4 - Application of Policy**

#### **Working Arrangements for Professional Staff**

(4) A professional staff member, including a shift worker, who works under the provisions of the <u>Flexible Working Arrangements Policy</u> may, in consultation with their nominated supervisor develop equitable working and overtime arrangements, which occur outside the following flexible working arrangement parameters:

- a. the normal weekly ordinary hours of work shall be 35, however, the maximum number of ordinary hours a staff member may be permitted to work in any week is 45 hours;
- b. the maximum number of ordinary hours a staff member may be permitted to work on any one day is 9 hours;
- c. the normal daily span of ordinary hours to be worked will be from 8:00 am to 6:00 pm, Monday to Friday but this may be extended to 7:30 am to 7:00 pm where it is essential to maintain a University service or activity;
- d. except in an emergency situation, a staff member will normally be given 48 hours notice if they are required to work during the period 7.30 am to 8:00 am or 6:00 pm to 7.00pm;
- e. overtime and shift allowances are not normally applicable between 7:30 am and 7:00 pm;
- f. with the approval of a Member of the Executive, a staff member may work ordinary hours outside the normal span of ordinary hours provided they are not required to do so under this provision;
- g. a staff member will normally work an average of no more than 140 hours over a four-week cycle;
- h. part-time staff will work the hours specified in their contract of employment over a four-week cycle (or the contracted period in the case of casual staff); and
- i. the ordinary hours of work for caretaking / cleaning / gardening / security staff shall be worked between 6:00

#### **Overtime Principles**

- (5) The University may direct a staff member to work a reasonable amount of overtime, unless the staff member has reasonable grounds for not working the overtime. In determining whether additional hours are reasonable or unreasonable, the following must be considered:
  - a. any risk to the staff member's health and safety from working the additional hours;
  - b. the staff member's personal circumstances, including family responsibilities;
  - c. the needs of the work unit in which the staff member works;
  - d. whether the staff member is entitled to receive overtime payments, penalty rates or other compensation for, or they receive a level of remuneration that reflects an expectation of, working additional hours;
  - e. the notice (if any) given by the University of any request or requirement to work the additional hours;
  - f. the notice (if any) given by the staff member of their intention to refuse to work the additional hours;
  - g. the usual patterns of work in the work unit;
  - h. the nature of the staff member's role, and the staff member's level of responsibility;
  - i. whether the additional hours are in accordance with the averaging provisions included in the <u>ACU Staff</u> <u>Enterprise Agreement 2022-2025</u>; and
  - j. any other relevant matter.
- (6) All authorised time worked in the following circumstances shall be treated as overtime and will be paid at the ordinary rate per hour in accordance with the following table:

Where there is not a minimum of 10 hours rest relief off duty prior to returning to duty until released from duty	200%

(7) Any period of overtime which is continuous with ordinary duty and which extends beyond midnight shall be deemed to have been performed on the day the overtime commenced.

- (8) Where overtime is not continuous with ordinary duty and involves duty before and after midnight, the overtime shall be deemed to have been worked on the day for which the higher rate is payable.
- (9) Overtime shall be calculated to the nearest five (5) minutes of the total amount of overtime worked in a work cycle.
- (10) The salary of a staff member for the purposes of calculating overtime does not include shift work allowances or the casual loading but does include any higher duties allowance or other allowances being paid to the staff member as part of their salary.

#### Meal Breaks and Meal Allowances

- (11) A staff member will not be required to work for more than five consecutive hours, without taking an unpaid meal break of at least 30 minutes.
- (12) A meal allowance shall be paid where:
  - a. the staff member is provided with less than 24 hours' notice of the requirement to work overtime;
  - b. the staff member works at least one and a half hours authorised overtime before or after their ordinary hours for the day / shift; and
  - c. such overtime is continuous with the staff member's normal hours for the day / shift except for any intervening meal break.
- (13) The meal allowance rate is \$37.65 and will be reviewed annually by the University, in line with changes in the CPI, but will not exceed the amount determined by the <u>Australian Taxation Office</u> guidelines.
- (14) Staff members who are eligible to claim a meal allowance should complete a <u>Staff Reimbursement Form</u> and email the completed form with the relevant supporting documentation to Accounts Payable (<u>accountspayable@acu.edu.au</u>) for processing.

#### Time-in-lieu

- (15) If a staff member is directed to work overtime, the staff member may request to take time off in lieu of overtime payment. Such time off is to be calculated in the same manner as is prescribed in clause (6).
- (16) A staff member may accumulate up to a maximum of 28 hours time-in-lieu after which payment must be made for any overtime worked. All time-in-lieu is to be cleared within three months of accrual unless otherwise agreed between the staff member and the supervisor. If the time off in lieu of overtime is not cleared within three months, in the absence of any other agreement the staff member shall be paid the monetary value of the accrued time-in-lieu.

#### **Staff Member Recalled to Duty**

- (17) A staff member who is required to work overtime which is not continuous with their ordinary duty shall receive a minimum of three hours overtime payment at the overtime rate detailed in clause (6), even though the period of duty may be less than three hours.
- (18) If a staff member, who is On-Call (as defined by the On Call Arrangements for Professional Staff Policy) is required to return to the University at any time outside the span of hours set out in clause (4), they will be paid a minimum of three hours overtime at the overtime rate detailed in clause (6), inclusive of travel time. Any additional return to the University for the same or related problem within the minimum overtime period will not attract further payment.
- (19) Where more than one overtime attendance is required for unrelated issues, the minimum payment provision shall not operate to increase the overtime payment beyond that amount which would have been payable had the staff

member remained on duty from the time of commencing one period of overtime to the time of ceasing a subsequent period of overtime.

#### **Rest Relief After Overtime**

- (20) A staff member required to work overtime in circumstances where there is not a break of at least 10 consecutive hours between the cessation of one period of duty and the commencement of the next ordinary period of duty shall be released from duty, without any loss of pay, for a period of at least 10 consecutive hours.
- (21) A staff member required by the University to resume or continue work without having had at least 10 consecutive hours, off duty shall be paid at the overtime rate detailed in clause (6) until released from duty for at least 10 consecutive hours and such release shall be without loss of pay.
- (22) Other than emergencies, the University will make all reasonable efforts to ensure that staff are not required to continue working without having had at least 10 consecutive hours off duty.

## **Section 5 - Approvals**

(23) All overtime worked must be authorised by the appropriate delegated officer in writing (e.g. by email) prior to the commencement of overtime. Overtime not authorised prior to the overtime being undertaken will not be paid as overtime. Information regarding the delegated officers is available in the <u>Delegations of Authority Policy and Register</u>.

### **Section 6 - Procedures**

- (24) A supervisor who requires a staff member to work overtime will write to the staff member by email. The email will detail the overtime hours and dates to be worked and will seek confirmation by a return email that the staff member is available and agrees to work the overtime required.
- (25) Staff members who are directed to work overtime are required to record their starting and finishing times and the timing of any breaks taken during the period of overtime.
- (26) The overtime hours should be recorded by completing a timesheet via Staff Connect, which will be presented to the staff member's supervisor for review.
